Details of approved registration:

The Vendor has been granted exclusive rights to operate at **Cades Bay Station** and its immediate environs during the PiAngo Fest on the aforementioned dates and are vested with the rights and duties of regulation and controlling all activities sale of food and therein.

- 1.1 Grant:** The Committee hereby grants to the Vendor the right to vend during the PiAngo Fest, Mango Pineapple products.
- 1.2** The Committee may from to time in its absolute discretion determine the right of the Vendor to operate.
- 1.3** The Vendor **CAN ONLY VEND at AUTHROIZED AREAS** outlined by the Committee.
- 1.4 Stall Signs:** The Vendor may place his/her name and the menu/products on a board or banner withing his/her allotted space.
- 1.5 Lighting:** The Vendor shall provide his or her own lighting.
- 1.6 Disposal of Refuse:** The vendor must deposit all vegetable and refuse etc. in the bins provided and dry refuse must be place by him/her in suitable receptacles kept inside the stall. The Vendor must keep the avenue adjoining his/her stall free from refuse and litter.

1.7 Nuisance etc.: The Vendor must not do or permit to be done anything which in the opinion of Committee may be a nuisance or annoyance to any member of the public resorting to the area or which may be detrimental to its efficient operation.

1.8 Covid Protocols:

- Vendor adhere to all Covid Protocols
- Face mask covering nose and mouth must be always worn.
- Vendor must have sanitizer for their use and customers usage.

CONDITIONS

This Registration is granted to the subject under the following conditions:

2.1 PAYMENTS:

- **20x20** space EC\$40.00

2.1.1 LATE FEES:

- EC\$50.00 late fee will be imposed for ALL registration done after the deadline date. 12:00p.m. **28th July 2022**

2.1.2 TENT:

- Tents Size should be no more than **20x20 or less.**

2.2 FOOD HANDLERS LICENSE:

- Where applicable, the Vendor must present an updated copy of their Food Handlers License upon registration and must have said License on them during the Fest.
- Persons handling Food in the Booth **must** also have an updated Food Handlers License
- Vendors must have adequate supply of ice and heating mechanism to maintain the temperature of food served.
- All Vendors must make available hand washing/sanitizing facilities for themselves and customers

2.3 COMPLIANCE WITH BYELAWS:

- The Vendor will comply with the rules of the Committee and any other regulations or rules made by the Committee with respect to vending.

2.4 USE BY OTHER PERSONS:

- The Vendor shall not permit any person other than his employee to use the stall, spot, or booth unless with the Committee permission

2.5 STALL BOUNDARIES:

- The Vendor may not place goods beyond the boundaries of the stall either on the ground or hanging except with the permission of the Committee.
